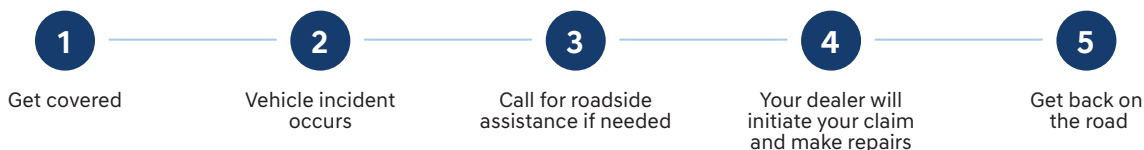

## How it works
